

## Invitation for Bids

The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of Water Resources Management in Pyanj River Basin Project, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.

2. The Project Implementation Group (PIG) under the SI "Capital and Land Reclamation Construction" under Agency for Land Reclamation and Irrigation (ALRI) of the Republic of Tajikistan ("the Purchaser") invites sealed bids from eligible bidders for the Procurement of heavy machinery for ALRI WUA Support Unit. The list of machinery, delivery period and location as follow:

3. **National Competitive Bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following **key qualifications** should participate in this bidding:

a) Historical Financial Performance	The bidder must demonstrate soundness of its financial position by submitting audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last three (3) years. As a minimum, the bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
b) Cash Flow Capacity	The bidder must demonstrate availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is \$ 200,000.0
c) Average Annual Turnover	Minimum average annual turnover: USD 400,000.00 calculated as total payments received by the Bidder for contracts completed or under execution over the last 5 (five) years.

d) Contractual Experience	Successful completion as main supplier within the last three (3) years, of at least two (2) contracts each valued at USD 160,000.00 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
e) Technical Experience	The Bidder shall demonstrate that the goods offered have: (i) been in production for at least five (5) years, and
	(ii) been sold a minimum of Twenty (20) units of similar type and specification over the last three (3) years;
	(iii) been in operation for a minimum of five (5) years.
